

Privacy Policy

This privacy policy explains how we, GTP Interiors use any personal information we collect about you when you use this website or contact us by phone or email.

What information do we collect about you?

We collect information about you when you contact us by phone or by email regarding an enquiry to use our services. We also collect information when you voluntarily complete the Account Application form. We cannot carry out a particular service until you have an account set up with the company.

How will we use the information about you?

We collect information about you to process your order/enquiry, manage your account, and if you agree, to email you containing important information with regards to marketing of products and the latest product offers.

We will only use your personal data when the law allows us to. In the day to day running of our business we may use your personal data without asking for your consent because:

- We are entering into and carrying out our obligations under a contract with you;
- We need to use your personal data for our own legitimate interest purposes (such as the administration and management of our business and the improvement of our services) which will comply with GDPR and your interests and fundamental rights do not override those interests.

Other types of legal basis that we rely on to process your personal data are included within this Privacy Policy.

We use your information collected from the website, emails and/or telephone calls to create quotes and provide you with information you require. In processing your enquiry/quote, we must send your information to third parties to proceed with your request.

Retaining your data

Your details will be retained internally securely, to primarily aid us in carrying out services for you in the future.

If for whatever reason, you will not be using our services in the future, then, if there are no outstanding, unpaid invoices on your account, you may request that your account be closed, and your details be removed from our internal systems.

Marketing

We would like to send you information about products and services of ours, which might be of interest to you. If you have consented to receive marketing, you may opt out at a later date.

You have a right at any time to stop us from contacting you for marketing purposes. Please contact us if you no longer wish to be contacted for marketing purposes.

Who do we share your personal information with?

In connection with the uses referred to above, we may disclose your personal information to certain third parties, including:

- External companies, who process our data in order to provide the service that you have requested GTP Interiors to undertake.
- Google (acting as data processors) for them to use on our behalf in connection with the creation of marketing and promotion for us. This may include Google using socio-demographic information about you to identify other people like you, with similar interests to present our marketing to. This socio-demographic information is not used for any other purpose nor shared with any other party. No information about other individuals identified from these networks is shared with us at any time. Your information is never made public and is not shared with any other third party.
- External agencies and organisations (including the police and other law enforcement agencies) for the purpose of preventing and detecting fraud (including fraudulent transactions) and criminal activity and for the assessment and collection of tax;
- Our insurers and other brokers and our and their advisers in the event that a claim is made or could be made against us.
- We may pass your personal information to third parties if we are under a duty to disclose or share your personal information in order to comply with any legal or regulatory obligation (including in connection with a court order), or in order to enforce or apply the agreements we have with or otherwise concerning you (including agreements between you and us (or one or more of our affiliates)); or to protect our rights, property or safety or those of our customers, employees or other third parties.
